Legislative District 32 Bylaws Adopted in Spring 2019

- 1. Reorganization
 - a. Reorganization will be held on a day that is in line with Idaho State Statute and conforms to the Idaho State Republican Party Rules.
 - b. Notification will be given within 7 days of the meeting and the meeting shall take place no later than 11 days after the Primary election.
 - c. The incumbent Legislative District Chair shall call the meeting, in the case of no meeting being called within 4 days of the primary, then the meeting will be held on the 11th day after the primary at 7pm at the Caribou County Courthouse.
 - d. The reorganization meeting shall be held at a County Courthouse in one of the counties contained inside of Legislative District 32 except as previously stated.
 - e. A quorum for the purposes of the reorganization meeting shall be considered to be fulfilled as long as at least one precinct committee person is present from 3 of the 6 counties in the Legislative District.
 - f. The meeting will be chaired by the incumbent Legislative District Chairman until after the election of the new Legislative District Chairman who will immediately take chair of the meeting.
 - i. In the event that the meeting was held by default of no call for the meeting then the majority of those present for the meeting will select a chair for the meeting by majority vote.
 - g. Elections shall be by secret ballot unless the position is uncontested. The decision of a majority of those present at the meeting shall constitute a decision for the position being voted on.
 - h. Elections shall be held for Chair, Vice Chair, and other positions the body deems necessary for the running on the Legislative District.
- 2. Selection of State Convention Delegates
 - a. The election of state delegates will follow the rules laid forth in the Idaho State Republican Party Rules.
 - i. The newly (re)elected Legislative District Chair shall not have a vote for the delegates to the State Convention except as explicitly stated in the state party rules as a tiebreaker in the event of a tie.
 - b. The attendees of the reorganizational meeting shall constitute a quorum for the election of delegates to the State Convention.

- 3. Regular Meetings
 - a. Regular Meetings will not be held at a physical location.
 - b. If matters come up that need a vote, that vote may be taken in each individual county meeting by the precinct people in that county.
 - c. After all County Chairs have voted and reported the count of the votes to the Legislative District Chair or informed the Legislative District Chair that no vote would be taking place, then the Legislative District Chair shall tally the votes reported and report those votes totals back to each County Chair to present at their next meeting.
 - d. Electronic methods of voting shall always be accepted by the Legislative District Chair and each precinct person may, at their discretion, report their own vote directly to the Legislative District Chair for inclusion in the final tally.
 - i. Only a precinct person who gives the Legislative District Chair their email, phone number, or other electronic communication information before the vote is to be cast, and is verified as the owner of that email, phone number, or other electronic communication information shall be able to vote in this manner.
 - e. The rules of Legislative District 32 may be amended via this method.
- 4. Vacancies in the Idaho State Legislature
 - a. The Legislative District will conform to all Idaho State Statutes regarding vacancies in the Idaho State Legislature.
 - i. If the Idaho State Republican Party Rules do not contradict Idaho State Statute then the Legislative District shall also follow the rules set forth in the Idaho State Republican Party Rules.
 - b. The Legislative District Chair will give 3 days notice and hold a meeting within 10 days of a vacancy being reported in the Idaho State Legislature.
 - c. The meeting shall be held at a county courthouse inside the Legislative District.
 - d. If no meeting is called, then a meeting will be held on the 10th day after the reported vacancy at the Caribou County Courthouse at 7pm.
 - e. The chair of the meeting shall be the Legislative District Chair unless the Chair did not call the meeting, then the majority of those present shall elect from amongst themselves one to chair the meeting.
 - f. A quorum for the purposes of filling a vacancy shall be considered to be fulfilled as long as at least one precinct committee person is present from 3 of the 6 counties in the Legislative District.
- 5. Adoption
 - a. Adoption of these rules is by the rules set forth under Article VII Section 2 of the Idaho State Republican Party Rules.
 - b. These rules were adopted after the consent and vote of committee persons of Legislative District 32.
